The Ministry of Manpower and the Workplace Safety and Health Council (WSHC), have enhanced the risk management framework 'Risk Management 2.0' (RM 2.0). This new framework includes the updating of the Code of Practice on WSH Risk Management to put more focus on Risk Evaluation for Health Hazards.
